


All Missouri voters should matter!



30.9% of eligible voters did not vote in 2016!

62.7% of eligible voters were NOT represented in the Electoral College in 2016! Only 37.3% of eligible voters were represented in the Electoral College in 2016! Simple Truth: It takes three registered voters to equal one viable presidential ballot!

Equal Voice Voting Formula:

- 1. Count the state's popular vote.
- 2. Determine Popular Vote Value (PVV).
- Divide the state's popular vote by the state's electoral votes (Missouri has 10).
- 3. Divide a candidate's state votes by the PVV to determine the number of electoral votes won.

2016 Example:

- 1. Missouri's popular vote = 2,808,605
- 2. 2,808,605 divided by 10 = 280,861 (Popular Vote Value)
- 3. Candidate votes divided by the PVV:
 - a. Clinton = 1,071,068 divided by 280,861 = 4 (adjusted whole number value)
 - b. Trump = 1,594,511 divided by 280,861 = 6 (adjusted whole number value)

Missouri had approximately 4,223,787 registered voters in 2016. Since Trump won the state's election with 1,594,511 votes, the remaining 2,629,276 registered voters were NOT represented in the Electoral College! Something must be done to correct the problem.

Equal Voice Voting will:

- Abolish the all-or-nothing approach for electoral vote allocation.
- Provide total popular vote representation.
- Retain and respect the Electoral College.
- Not require a Constitutional amendment.
- Modify how Oregon translates popular votes into electoral votes.
- Encourage greater voter engagement.
- Be easy to implement (simple math).
